
We appreciate all of our suppliers and supporters and welcome those participating in this year's 2025 Conference and the Oklahoma Food and Beverage

### **LEGISLATIVE REPORT • D.R. Roberts Strategies**



During this legislative session, a total of 3,204 bills were filed. Of these, 28 bills were identified as potentially affecting our industry. Currently, eight of these bills are still in the legislative process, and we're actively monitoring their progress.

The current session is marked by a significant budgetary challenge, with the state facing a \$400-million budget shortfall. This fiscal constraint has made it

difficult for bills with substantial financial impacts to pass, as they face additional scrutiny.

Additionally, there is a notable divergence in economic priorities between the governor and the Legislature. While the governor is advocating for personal income tax cuts, the Legislature aims to maintain a flat budget.

### MAIN FOCUS BILLS:

### 1. HB 1024/SB 638

Status: Awaiting hearings in both chambers.

**Description:** The bill proposes the removal of the 6% minimum markup requirement on products at retail, which

would have significant financial implications.

**Action:** We are focused on ensuring the fuel exemption remains in place and are monitoring the progress of this bill closely.

### 2. SB 4

**Status:** Did not receive a hearing on the Senate floor.

**Description:** This bill proposed a ban on all red dyes and other food dyes in Oklahoma. While it has not progressed to a hearing, we are continuing to track its status in case it resurfaces or is modified.

**Action:** No immediate action required, but we remain prepared for future developments.

### 3. SB 1102

**Status:** Passed the Senate, awaiting a hearing in the House. **Description:** This bill establishes the enforcement mechanism for the vape directory, a significant step for the regulation of the vaping industry in Oklahoma.

**Action:** We are preparing for the hearing in the House and are focused on ensuring the enforcement provisions align with industry needs.



She attended Van Buren High School and is currently studying nursing at the University of Central Arkansas.


Nayeli is a certified nurse aide and BLS (biliteracy). She has



### FROM THE CDA PRESIDENT

Welcome to the 2025 Convenience Distributors of Oklahoma (CDO) Annual Conference! This is an excellent forum that brings inspired people together to ensure our industry remains at the cutting edge.

Each year, the Convenience Distribution Association (CDA) takes the pulse of the industry by surveying its distributor members about the present and the future. What's working well? What needs improvement? What's causing worries? And what brings hope?

This year, members responded in record numbers. And the good news is that the vast majority of respondents feel optimistic about the state of the industry. Nearly 60% anticipate sales to increase in 2025, with about 80% expecting net profits to hold steady or grow.

Tempering that optimism are concerns about inflation and excessive government regulation. But the strategies distributors shared about moving their businesses forward show the tenacity and vision of distributors.

When contemplating the state of the convenience distribution industry, distributors say that inflation, government regulations and labor are the three areas of greatest concern. Exit polls from last year's presidential election showed that voters were most concerned about the economy. Those anxieties were reflected in CDA's survey as well with almost 55% of respondents identifying inflationary pressures as their most pressing business issue.

We know distributors are working hard to grow sales and increase profitability. The top growth strategy (83%) is finding new customers in existing markets. Additionally, more than 60% hope to grow their food service programs, and 44% plan price increases as a way to grow their business.

A successful business is not all about sales. Some 80% of respondents are taking steps to increase operational efficiencies. Of those, 43% are focusing on improved employee productivity, and 40% plan to enhance margins through better use of technology.

The role of government regulation is never far from distributors' minds. Notably, 49% of respondents put regulation as their second-most important business consideration, right after inflation.

In fact, one distributor said that government regulations actually are his top three concerns - by treating federal, state and local regulations separately.

Even as the industry is changing, tobacco remains front and center for convenience distributors.

The top tobacco issues cited by respondents were:

- The lack of enforcement of illicit vapes by the federal government: 77%
- The FDA's slow premarket tobacco product application (PMTA) process: 67%

Because federal regulatory issues are such a dominant concern, it's no surprise that 79% of respondents contact their elected officials in Washington at least occasionally. That is critically important! Please make your voice heard individually and collectively with both CDO and CDA.

CDA makes it easy for members to communicate with officials by sharing information via CDA government affairs news bulletins, subject matter webinars and through events like the annual Day on the Hill advocacy program in Washington, D.C. Wholesale distributors have significant growth opportunities in 2025. Even with the uncertainties that lie ahead. these challenges may push companies to embrace technology, invest in employee development and more actively pursue growth in food service and other sectors.
